AGREEMENTDESCRIPTION



This agreement will continue until terminated, following inflation, and includes one preventative maintenance visit per year. This agreement is offered to clients who have a minimum of 3 pieces of equipment included in the list on page one, above. The agreement also includes the following services:

- Important: Prices for the agreement are subject to change without notice.

IMPORTANT

A preventative maintenance agreement is not an extended warranty of your product. Our goal is to maximize the life of your product at a reasonable cost. Products which have not previously been maintained or have not been maintained properly are subject to unpredictable breakage. Our representatives will guide you when major repairs are suggested. Depending on the age and use of your equipment, it is sometimes preferable to replace a product rather than repair it.





PREAMBLE

Agreed that the customer would like to retain the services of Dispomed Ltd, as previously described, within the framework of the veterinary machines preventative maintenance;

Agreed that the parties wish to confirm their agreement in writing;

Agreed that the parties have the capacity and quality to exercise all the required rights to conclude and execute the agreement of the present agreement.

LENGTH OF AGREEMENT

1. The length of the agreement is continued until terminated.

SERVICES

2. Dispormed Ltd agrees to supply the services described according to the customer's instructions and to his/her satisfaction.

COUNTERPARTY

In exchange of the supplied services, the customer agrees to pay Disposed Ltd.
according to agreement described previously, plus all parts needed to perform the
preventative maintenance.

Invoices will be issued after each visit and will be payable on a 30 day payment term.

NON-EXCLUSIVE SERVICES

4. The customer acknowledges and agrees that the services supplied by Dispomed Ltd, in virtue of the present agreement, are not exclusive. No disposition of the present agreement may be interpreted as limiting the capacity of Dispomed Ltd to supply its services to a third party during the period of the present agreement, subject to the respect of its obligations such as defined in the present agreement.

CONFIDENTIALITY

- 5. Dispomed Ltd agrees to not disclose to a third party:
- 5.1. Any confidential information regarding the customer's business, including commercial secrets, business plans, financial and customer data that might have been acquired within the framework of work performed in your place of business.





TERMINATION AND CANCELLATION OF THE PRESENT AGREEMENT

- 6. Should one of the parties fail to respect one or another of its obligations in virtue of the present agreement, the other party can cancel the present agreement with a written 10 business day notice, unless the party in cause remedies the evoked situation within the aforementioned delay. In case of cancellation of the present agreement, the customer must pay all bills due to Dispomed Ltd for supplied services at the date of cancellation. The customer will complete and sign the Maintenance Agreement Cancellation form found on the last page of this agreement if he/she wishes to terminate their agreement with Dispomed.
- 7. The foreclosure, insolvency or transfer of possession by one or the other party establishes a fault that terminates the present agreement as of right.
- 8. Within cancellation of the present agreement by one or the other party, Disposed Ltd agrees to return to the customer all materials used in the execution of the present agreement or otherwise belonging to the customer within a 14 day delay.

REPRESENTATIONS AND WARRANTIES

- 9. Dispomed Ltd represents and guarantees to the customer that:
- 9.1. It has the capacity and quality to exercise all required rights to conclude and execute the present agreement;
- 9.2. It has all the rights, titles and interest of services and work material;
- 9.3. It will not engage any cost, expense or obligation in the customer's name without receiving written authorization.

RELATIONSHIP BETWEEN THE PARTIES

10. The present agreement only binds the parties, being independent businesses, for the clauses mentioned in this agreement. Consequently, the enactments of the present agreement can be interpreted by no means as creating a mandate from one to the other. Furthermore, no party can bind the other, in any way or to whomever, otherwise than in accordance with the enactments of the present agreement.

ACT OF GOD

11. No parties can be considered in default in virtue of the present agreement if the execution of its obligations, in any part, is delayed or prevented by an act of God. An act of God is an outside, unforeseen, event that makes it impossible to execute its obligations.

INDEPENDANCE OF ENACTMENTS

12. The possible illegality or nullity of an article, paragraph or enactment (or part of an article, paragraph or enactment) will not affect in any way the legality of the other articles, paragraphs or enactments of the present agreement, nor the rest of this article, paragraph or enactment, unless evident opposite intention in the text.





TRANSFER AND IMPACT OF AGREEMENT

13. Disported Ltd cannot assign or otherwise transfer all or any of its rights stipulated in the present agreement to a third party.

TOTALITY AND COMPLETENESS OF THE AGREEMENT

- 14. The present agreement represents the totality and completeness of the agreement between the parties.
- 15. No statement, representation, promise or condition not specified in the present agreement can and be allowed to contradict, modify or affect in any way possible its terms. The present agreement can only be modified by another written document, duly signed by all parties.

COPIES

16. Once initialled and signed by both parties, all copies of the present agreement are considered as being an original, as the copies reflect the same and present agreement. The transmission and signature of the present agreement by fax also bind both parties.





Dispormed agrees to rent/loan the equipment described in the section Equipment List to you upon acceptance of the following terms and conditions:

- We do not have courtesy scales or oxygen generators available.
- You, the client, agree to have your damaged equipment repaired by Dispomed.
- You, the client, agree to send your equipment to the Disposed repair shop within 2 days of receiving the rental/loaner equipment.
- You, the client, agree to submit your response to our repair quote within 3 days:
 - > If the quote is refused, you agree to return the Dispormed equipment within 2 days of refusal;
 - > If the quote is accepted, you, agree to return the Dispomed equipment within 2 days of receiving your repaired equipment.
- You, the client, agree to return all accessories that were sent with the rented/loaned equipment. Any costs to replace missing parts will be invoiced to you.
- You, the client, are responsible for any breakages that occur during the time that
 the rented/loaned equipment is in your clinic. All costs incurred for repair will be invoiced
 to you.
- The initial rental cost varies by product (refer to the price list on page 3). All shipping charges related to equipment rentals or loans are the responsibility of the client.
- Courtesy equipment will be invoiced based on the product type (see price list on page 3) in the following situations:
 - >We haven't received your equipment to evaluate and/or to repair within (2) business days after reception of our courtesy equipment. Fees may be waived if replacement of equipment is considered instead of repairs and the said equipment is purchased from Dispomed;
 - Our courtesy equipment is not returned within (2) business days after reception of your equipment, repaired or not;
 - > In both cases, no fees will be invoiced if the delay is caused by the shipping company (tracking info required as proof).

- Travel charges are based on 1 preventative maintenance visit per year. Fees will be invoiced for each additional visit requested during the year.
- Travel charges vary according to region.
- When there is a large quantity of units, and the technician cannot complete the maintenance in the same day, travel charges will be invoiced for each visit.
- If a piece of equipment is not made available during the technician's scheduled maintenance visit and he must return, travel charges will be invoiced for each visit.
- If the technician does not have the parts necessary to complete the scheduled maintenance and must return, travel charges will not be charged for the return visit.
- Training for your employees may be requested during the technician's visit. Training will be invoiced at the hourly rate described in the table above, at Dispomed's discretion.

NOTE: All parts used during preventative maintenance will be charged in addition to fees quoted above. Disposed will advise the client before proceeding with any repair which is not part of preventative maintenance and therefore not included in this agreement.
